FUND OBJECTIVE

The Sesfikile Boutique Collective Investments Property Fund Class A is a portfolio which aims to deliver both a high income yield as well as capital growth over the medium to long term. Our objective is to deliver total returns (consisting of income and capital) that outperform the FTSE/JSE All Property Index (J803) over a 3 to 5 year investment horizon. The fund is suitable for investors who are looking for a viable property component to a balanced portfolio; or alternatively an investor looking for a growing income stream but is willing to be exposed to an element of capital volatility.





FUND STRATEGY

This fund aims to outperform the benchmark by investing in listed property companies with sustainable income growth underpinned by strong property fundamentals. In addition to these core holdings, the fund makes use of tactical stock selection to capitalise on short-term market mispricing and corporate action opportunities.

INVESTMENT POLICY

The policy is to invest in JSE listed Real Estate Investment Trusts ("REITs") or listed property companies. The investment manager will also be allowed to invest in financial instruments and cash as allowed by the act from time to time in order to achieve its investment objective. Furthermore, and as legislation permits, the manager shall be permitted to invest in offshore listed property investments on behalf of the **Sesfikile BCI Property Fund**.

The fund offers active best of breed management within a sector that offers income and capital growth over time:

FUND MANAGER INFORMATION

The three founding directors, Evan Jankelowitz, Mohamed Kalla and Kundayi Munzara co-manage the Sesfikile BCI Property Fund.

The Sesfikile Investment Team, which consists of five individuals, boasts combined experience of almost 60 years in the listed property sector, making them amongst the most experienced teams in the market. Since inception, the Team has been able to deliver consistent benchmark and peer relative outperformance.

MARKET REVIEW

Listed property drifted slightly lower in May, losing -0.5% and -0.8% for the ALPI and SAPY indices respectively. The sector was, compared to recent months, quite uneventful as it lost some ground into the middle of the month only to claw some performance back into month end. It was disappointing that property didn't fare better considering local bonds continued to rally as yields breached 9.0% from a starting point of 10.3%. The South African relative yield carry seems to have reigned in bond yields to pre-Covid-19 levels, despite the recent Moodys downgrade to sub-investment grade. Bonds delivered +7.0% for the month, while Equities only delivered +0.3%, albeit off a strong +14.0% return in April.

As lockdowns ease and business returns to some level of normality, we are gaining further clarity on the impact on REITs' rental collections over the past two months. On average, REITs have collected about 65% of rentals during April, and while most companies are yet to publish May collections, anecdotal evidence suggests May's collections have been slightly better than April. Retail has, for obvious reasons, seen collection rates average 40 to 50% of normal levels, although some retail with a heavy bias to essential trade, such as Fairvest has fared better with collection rates as high as 86%. Office and industrial collection rates have varied depending on the exposure to SME's, but on a whole average 75%.

Balance sheets continue to be in focus; however we are seeing, that at least for the short term, banks are being pragmatic with regards to covenant breaches. We are also seeing a concerted effort from several companies to dispose of assets and retain distributions to alleviate balance sheet stress.

As at the end of May the sector is either screening significant value or further unforeseen pain beyond what an already bearish investor is already pricing in. There are still many uncertainties in the months ahead, primarily the impact of the Covid-19 lockdowns and the resultant impact on an already struggling economy. However with all this said the valuations are effectively pricing for business failure across many stocks, which we don't believe is the case.
