## FUND OBJECTIVE

The Sesfikile Boutique Collective Investments Property Fund Class A is a portfolio which aims to deliver both a high income yield as well as capital growth over the medium to long term. Our objective is to deliver total returns (consisting of income and capital) that outperform the FTSE/JSE All Property Index (J803) over a 3 to 5 year investment horizon. The fund is suitable for investors who are looking for a viable property component to a balanced portfolio; or alternatively an investor looking for a growing income stream but is willing to be exposed to an element of capital volatility.





## FUND STRATEGY

This fund aims to outperform the benchmark by investing in listed property companies with sustainable income growth underpinned by strong property fundamentals. In addition to these core holdings, the fund makes use of tactical stock selection to capitalise on short-term market mispricing and corporate action opportunities.

## INVESTMENT POLICY

The policy is to invest in JSE listed Real Estate Investment Trusts ("REITs") or listed property companies. The investment manager will also be allowed to invest in financial instruments and cash as allowed by the act from time to time in order to achieve its investment objective. Furthermore, and as legislation permits, the manager shall be permitted to invest in offshore listed property investments on behalf of the **Sesfikile BCI Property Fund**.

The fund offers active best of breed management within a sector that offers income and capital growth over time:

## FUND MANAGER INFORMATION

The three founding directors, Evan Jankelowitz, Mohamed Kalla and Kundayi Munzara co-manage the Sesfikile BCI Property Fund.

The Sesfikile Investment Team, which consists of five individuals, boasts combined experience of almost 60 years in the listed property sector, making them amongst the most experienced teams in the market. Since inception, the Team has been able to deliver consistent benchmark and peer relative outperformance.

## MARKET REVIEW

Listed property got off to a poor start for the fourth quarter as October saw the ALPI and SAPY lose 7.9% and 8.5% respectively. The long bond yield came in slightly from 9.65% to 9.58% resulting in a positive 0.9% return for the ALBI, while equities stumbled, losing 4.7%. Listed property continued to lose material ground against other asset classes with no visible justification.

One distinction in the month of October was that there were several stocks that delivered healthy positive returns. Hyprop was up 22.3% on the back of talks to sell a South African asset, a move much needed to help repair their balance sheet, while Arrowhead B, Fortress B, Fairvest and SA Corporate were all up in the teens. Unfortunately, weighing down on the sector were sector heavyweights Growthpoint, NEPI Rockcastle, Redefine and Resilient all delivering negative teen returns.

Locally the notable event was the medium term budget, which highlighted what was already known - the debt crunch the country faces should we fail to implement much needed reforms. Although there was much apprehension leading up to the event, there was no significant reaction to the meeting. Globally, the run up to the US election took centre stage with an expectation of volatility especially as both parties had expressed their mistrust of their opponent and if either would accept defeat. While the noise of the US election dominated headlines, in the background the Covid-19 spike in the northern hemisphere was gaining significant traction. Europe headed back into lockdowns and risk tolerance faded across investment markets.

We remain of the view that there is significant value in the sector, which has been created by the overly pessimistic assumptions as to the health of several stocks' balance sheets. We have done in-depth work surrounding this matter and believe that the vast majority of the sector have enough tools at their disposal to remain a going concern despite valuations indicating otherwise.
